4. FIRST AID MEASURES

If inhaled

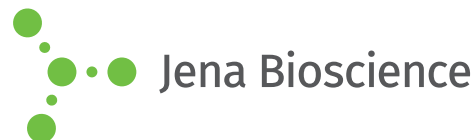
