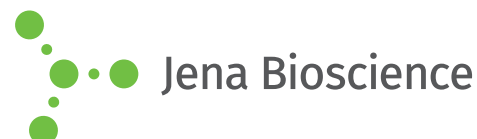

Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

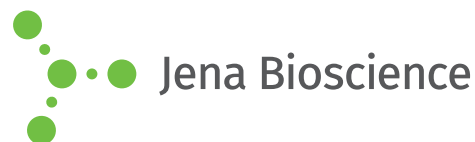

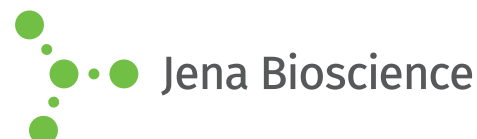

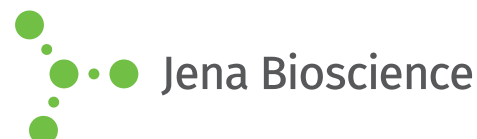
